



## Privacy Policy

Tigloo Ltd. (the "Company" and / or the "Operator") is the owner and operator of the \_\_\_\_\_ website (www.\_\_\_\_\_), which includes sub-sites and related sites (together and separately the "Site"). The detailed privacy policy The following is intended to regulate the entire issue of privacy on the site. The said privacy policy applies to all services offered on the site.

### **The information collected**

As part of the use of the website, which requires the provision of personal information, you will be asked to provide a number of personal data, such as: full name, telephone number, e-mail address and more. This data will be transmitted and stored in the operator's database in accordance with the provisions of the Privacy Protection Law, 5741-1981 (the "Law"). It will be emphasized that the provision of the above data by you is not required by law, but without providing the data defined on the website you will not be able to use the services offered on the site, such as advertising on the site's services.

Since the company will only request the information necessary for the service to which you are subscribed, in some of the services you will be asked to add and provide data regarding the nature of the service requested by you.

### **The use of information**

Your use of the site, as well as the use of other users, may lead to the collection of information and data about the type of activity you performed on the site such as advertising in the site boards, browsing specific pages / sections appearing on the site etc.

This information, as well as the personal information about you ("the information) - as long as you provide such - will be stored in the company's database. The Operator hereby undertakes to use the personal information about you subject to the provisions of any law and in accordance with the principles of use policy and privacy policy.

The use of the information collected by the company, insofar as it is collected, is specific to the following uses, among others:

- Send system updates and updates about your ads.
- Customization of components and topics on the site according to your various areas of interest and expectations.
- Customization of ads and advertisements uploaded on the site and / or other sites.
- Allowing the purchase or sale of various products.
- Providing the various services on the site, including locating and preventing prohibited activity on the site and impersonating others. We share this information with a third party that provides us with these services.
- Subject to your approval, receipt / sending of e-mails and / or text messages to telephones and contacting you in other ways subject to the provisions of the law. In this framework, the company will be able to bring to your attention various promotions that may be of interest to you, additional information on the website regarding the company's areas of activity and more. If in the future you are interested in terminating this service, all you have to do is enter the personal area and change the settings and / or alternatively notify the company of the contact details listed above and the service will be terminated.
- Anonymous information collected for statistical research of the company and / or third parties may be used in general, improving the services provided within the site, changing and streamlining the site structure, expanding or reducing the site's areas of activity and other purposes at the operator's discretion. .

### **Transfer of information to third parties**

As part of the Company's activities and the Website, the Company may from time to time transfer information and details of its users to third parties, provided that they have given their express consent to this prior to the transfer of the details. In addition, as part of the company's and website's activities, the company may from time to time transmit public information, which is published in the website ads to third parties, for the purpose of offering and providing ancillary services related to the ads.

### **Right of access to information**

By law, every person is entitled to review by himself, or by his authorized representative in writing or by his guardian, the information held in his respect in the operator's database. In order to receive this information you may and will be required to present identifying documents, including proof of ownership by telephone or e-mail. If you find the information in the operator's database incorrect, complete, clear or out of date, you may contact the operator to correct the information or delete it.

### **Collection of data by the company using "COOKIES"**

The company, similar to advertising companies, also creates "COOKIES" files on your personal computer from which it collects information regarding your type of sites, your ways of accessing these sites, the type of information you usually seek to find on the Internet, your interests, etc. The information collected through the "COOKIES" is used by the company for internal and self-use only, in order to improve and update the site so that it optimally meets your expectations, and is subject to the obligations and limitations that the company undertakes under the terms of use.

We will emphasize again that you can delete and / or completely prevent the creation of "COOKIES" files on your computer by changing the relevant settings, but this will require you to update your username and password in the future in cases where registration of these details is required by the service you request on the site. At the same time, it is important to note that the company's websites will not operate properly where a block for installing cookies has been activated.

### **Data Security**

The operator secures the information contained on the site and in its computer network insofar as it relates to the operation of the site, in the most advanced systems and in accordance with the law. Despite the efforts and resources invested in this, the operator can not guarantee to the users that illegal intrusion into the databases included in the website and the computer network will not be allowed.
